- a) The EC discussed the need to develop a different name for EC conference content considering that conference BOFs cannot record because of a policy. EC

Conference content includes Digital Arts events, IRC events, SIGGRAPH Town Halls, etc.

- i) The EC agreed that many of the EC programs have a need to record, but that it could be hard to differentiate between conference and EC BOFs for recording purposes.

### **4) Debrief of SGB Meeting (Adam B.)**

- b) The Chair reported on the latest SGB meeting to the group and discussed a new database being created by ACM. Any EC members with concerns or questions should direct them to Adam B. and Jessica.

### **5) Debrief on Meeting with Barbara Ryan, ACM (Adam B.)**

- c) Adam B. reported on the recent meeting he had with Barbara Ryan at ACM who is the expert on permissions. Through that call, he received a new permission form and sent it to various people to comment on.
- d) Adam and Barbara are looking to try out the new form with events over the next few months and hope it can be refined for use at the conference.
  - i) It was noted that the SIGGRAPH conference has deadlines that are sooner than a couple of months.
    - (1) Adam clarified that SIGGRAPH could be a big test of the forms. However, there are planned events happening before the conference that they plan to use to refine and test the forms as a few use cases to see how well they work.
  - ii) There will be calls moving forward to discuss this process more in-depth, and it was noted that Victoria Szabo should be on the call as this issue is affecting DAC as well.
