[We] wanted to start with a smaller audience to discuss the proposal. 2. Second meeting was attended by the same group plus the DEI Committee. It was a great meeting and it was good to clarify matters for the committee. <ol style="list-style-type: none"> a. At the meeting we tried to separate the ideas of converting the committee from a Standing Committee to an Advisory Group and the committee focusing on what their mission is. They admitted to having a backlog of projects, for example, a plan for an organizational focused DEI initiatives. b.
